Section 3 Hazard Identification

Emergency Overview: This product is an amber fluid liquid with a solvent type odor and flash point of 106°F. Due to its low viscosity this material poses an aspiration hazard if swallowed.

Potential Acute Health Effects:

Eye: Exposure may cause eye irritation. Symptoms may include stinging, tearing, and redness.

Skin: Exposure may cause skin irritation. Prolonged or repeated exposure may dry the skin. Symptoms may include redness, burning, drying and cracking, and skin burns. Pre-existing skin disorders may be aggravated by exposure to this material.

Ingestion: May be harmful if swallowed. This material poses an aspiration hazard if swallowed. Swallowing the liquid may cause aspiration into the lungs with the risk of

Section 4 First Aid Measures

Eye Contact: Immediately flush eyes with large amounts of water for at least 15 minutes. If symptoms persist or there is any visual difficulty, seek medical attention.

wool or waste in a sealed water-filled container. Dispose of contaminated absorbent, container and unused contents in accordance with local, state and federal regulations.

Section 6 Accidental Release Measures

Clean Up Methods: For small spills absorb liquid on vermiculite, floor absorbent or other absorbent material. For larger spills eliminate all ignition sources (flares, flames, including pilot lights, electrical sparks). Persons not wearing protective equipment should be excluded from area of spill until clean-up has been completed. Stop spill at source. Prevent from entering drains, sewers, streams or other bodies of water. Prevent from spreading. If runoff occurs, notify authorities as required. Pump or vacuum transfer spilled product to clean containers for recovery. Absorb unrecoverable product. Transfer contaminated absorbent, soil and other materials to containers for disposal. Prevent run-off to sewers, streams or other bodies of water. If run-off occurs, notify proper authorities as required that a spill has occurred.

Section 7 Handling and Storage

Handling: Avoid prolonged skin contact. Do not breathe spray mist

Storage: Store away from heat, sparks, and open flame.

Other Precautions: Ground containers when pouring and limit free-fall to a few inches to prevent static sparks. Avoid spontaneous combustion of contaminated rags or other easily ignitable organic accumulations by immediate immersion in water. Emptied containers may retain hazardous properties. Do not cut, puncture or weld on or near the container.

Engineering Controls: Use in well-ventilated areas. If necessary, use mechanical local exhaust ventilation or general room dilution ventilation to reduce vapor concentrations below applicable exposure limits.

Personal Protective Equipment (PPE):
