

# 4. First-Aid Measures

# 6. Accidental Release Measures

# 7. Handling and Storage

Do not store above 120°F (49°C). Store large quantities in buildings designed and protected for storage of NFPA Class II combustible liquids. ## 8. Exposure Controls / Personal Protection

#### PERSONAL PROTECTION

# 10. Stability and Reactivity
