**4. First-Aid Measures**

**FIRST AID - EYE CONTACT:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

**FIRST AID - SKIN CONTACT:** Wash skin with soap and water. Remove contaminated clothing. Get medical attention if irritation develops or persists.

**5. Fire-Fighting Measures**

## 6. Accidental Release Measures

## 7. Handling and Storage

**STORAGE:** Store in a dry, well ventilated place. Keep container tightly closed when not in use. Keep containers tightly closed. Isolate from heat, electrical equipment, sparks and open flame. Do not store above 120°F (49°C). Store large quantities in buildings designed and protected for storage of NFPA Class II combustible liquids. ### PERSONAL PROTECTION

## 10. Stability and Reactivity

**Conditions to Avoid:** Avoid temperatures above 120°F (49°C). Avoid all possible sources of ignition. Avoid excess heat. Keep from freezing.

**Incompatibility:** Incompatible with strong oxidizing agents, strong acids and strong alkalis.

**Hazardous Decomposition:** By open flame, carbon monoxide and carbon dioxide. When heated to decomposition, it emits acrid smoke and irritating fumes. Contains solvents which may form carbon monoxide, carbon dioxide, and formaldehyde.
