# 4. First-Aid Measures

#### 10. Stability and Reactivity

#### Conditions to Avoid: No Information

**Incompatibility:** Incompatible with strong oxidizing agents, strong acids and strong alkalies. Incommpatible with oxidizing materials, acetaldehyde, acids, bases, and chlorine.

Hazardous Decomposition: When heated to decomposition, it emits acrid smoke and irritating fumes. Contains solvents which may form carbon monoxide, carbon dioxide, and formaldehyde.

# 11. Toxicological Information

EFFECTS OF OVEREXPOSURE - EYE CONTACT: Substance causes moderate eye irritation.

Constituents may also contain asbestiform or non-asbestiform tremolite or other silicates as impurities, and above de minimus exposure to these impurities in inhalable form may be carcinogenic or cause other serious lung problems.
