# 4. First Aid Measures

# 10. Stability and Reactivity

**Conditions to Avoid:** Avoid temperatures above 120°F (49°C). Avoid all possible sources of ignition. Flammable hydrogen gas will evolve when product comes in contact with water or damp air.
