### 4. First Aid Measures

**First Aid - Eye Contact:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

## 5. Fire-Fighting Measures

## 6. Accidental Release Measures

## 7. Handling and Storage

### PERSONAL PROTECTION

## 10. Stability and Reactivity

**Conditions to Avoid:** Avoid temperatures above 120°F (49°C). Avoid all possible sources of ignition. Avoid excess heat.

**Incompatibility:** Incompatible with strong oxidizing agents, strong acids and strong alkalis.

**Hazardous Decomposition:** By open flame, carbon monoxide and carbon dioxide. When heated to decomposition, it emits acrid smoke and irritating fumes.

## 11. Toxicological Information

**Effects of Overexposure - Eye Contact:** Causes eye irritation. Irritating, and may injure eye tissue if not removed promptly.

**Effects of Overexposure - Skin Contact:** Prolonged or repeated skin contact may cause irritation. May cause skin irritation. Causes skin irritation. Allergic reactions are possible. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material. Frequent or prolonged contact may irritate the skin and cause a skin rash (dermatitis). Low hazard for usual industrial handling or commercial handling by trained personnel.

**Effects of Overexposure - Inhalation:** Harmful if inhaled. High gas, vapor, mist or dust concentrations may be harmful if inhaled. Avoid breathing fumes, spray, vapors, or mist. May cause headaches and dizziness. High vapor concentrations are irritating to the eyes, nose, throat and lungs. Constituents of this product include crystalline silica dust which, if inhalable, may cause silicosis, a form of progressive pulmonary fibrosis. **Effects of Overexposure - Ingestion:** Substance may be harmful if swallowed. Aspiration hazard if swallowed; can enter lungs and cause damage.

**Effects of Overexposure - Chronic Hazards:** May damage fertility or the unborn child. High concentrations may lead to central nervous system effects (drowsiness, dizziness, nausea, headaches, paralysis, and blurred vision) and/or damage. Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage. Contains Titanium Dioxide. Titanium Dioxide is listed as a Group 2B-"Possibly carcinogenic to humans" by IARC.
