10. Stability and Reactivity

Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage. Significant exposure is not anticipated during brush application or drying. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of carbon black in the formula. IARC lists Ethylbenzene as a possible human carcinogen (group 2B).
