# 4. First-Aid Measures

# 10. Stability and Reactivity

## 11. Toxicological Information

EFFECTS OF OVEREXPOSURE - EYE CONTACT: Irritating, and may injure eye tissue if not removed promptly. May cause eye irritation.

**EFFECTS OF OVEREXPOSURE - SKIN CONTACT:** Low hazard for usual industrial handling or commercial handling by trained personnel. May cause severe irritation. **EFFECTS OF OVEREXPOSURE - INGESTION:** Expected to be a low ingestion hazard. May cause obstruction in stomach, as it hardens with moisture. Symptoms include stomach pain, distress. Drinking glycerin, gelatin solutions, or large volumes of water may delay the hardening of calcium sulfate in the stomach. Surgical relief of obstruction, particularly at the pylorus, may be necessary.
