4. First-Aid Measures

FIRST AID - EYE CONTACT: Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

6. Accidental Release Measures

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED: If spilled, contain spilled material and remove with inert absorbent. Absorb with non-combustible liquid-binding material (sand, diatomaceous earth (clay), acid binders, universal binders). 7. Handling and Storage

Follow all SDS and label precautions even after container is emptied because it may retain product residues. Avoid breathing fumes, vapors, or mist. Avoid contact with eyes, skin and clothing. Rags, steel wool, or waste contaminated with this product may spontaneously catch fire if improperly discarded. Immediately after use, place contaminated materials in a sealed, water-filled metal container.

STORAGE: Store in a dry, well ventilated place. Keep container tightly closed when not in use.
