4. First-Aid Measures

Overexposure to methyl ethyl ketone in laboratory animals has been associated with liver abnormalities, kidney and lung damage. Fetotoxic/embryotoxic effects from inhalation have been seen in rats exposed to >1000ppm during gestation. Contains carbon black.
