### 4. First-Aid Measures

**FIRST AID - EYE CONTACT:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

**FIRST AID - SKIN CONTACT:** Immediately flush skin with plenty of water for at least 15 minutes while removing clothing. Get medical attention immediately. Wash clothing separately before reuse.

**FIRST AID - INHALATION:** Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get immediate medical attention. ### 5. Fire-Fighting Measures

**EXTINGUISHING MEDIA:** Dry Chemical, Dry Sand

**UNUSUAL FIRE AND EXPLOSION HAZARDS:** Closed containers may explode when exposed to extreme heat. Keep containers tightly closed. Perforation of the pressurized container may cause bursting of the can.

**SPECIAL FIREFIGHTING PROCEDURES:** Water may be used to cool closed containers to prevent buildup of steam. Full protective equipment including self-contained breathing apparatus should be used. If water is used, fog nozzles are preferred. Evacuate area and fight fire from a safe distance. Containers can rupture and release highly toxic material if exposed to heat. Substance is non-combustible but reacts with many metals to form explosive hydrogen gas. Use water spray to keep fire-exposed containers cool. Containers may explode when heated.

### 6. Accidental Release Measures
