4. First-Aid Measures

First Aid - Eye Contact: Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

10. Stability and Reactivity

11. Toxicological Information

Effects of Overexposure - Eye Contact: Irritating, and may injure eye tissue if not removed promptly.

Effects of Overexposure - Skin Contact: Prolonged or repeated skin contact may cause irritation. Causes skin irritation. Allergic reactions are possible. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material. Frequent or prolonged contact may irritate the skin and cause a skin rash (dermatitis).
