4. First-Aid Measures

First Aid - Eye Contact: Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

5. Fire-Fighting Measures

10. Stability and Reactivity

11. Toxicological Information

Effects of Overexposure - Eye Contact: Causes eye irritation. Irritating, and may injure eye tissue if not removed promptly.

Effects of Overexposure - Skin Contact: Prolonged or repeated skin contact may cause irritation. Causes skin irritation. Allergic reactions are possible. Effects of Overexposure - Chronic Hazards: High concentrations may lead to central nervous system effects (drowsiness, dizziness, nausea, headaches, paralysis, and blurred vision) and/or damage.
