### 4. First-Aid Measures

**FIRST AID - EYE CONTACT:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

**FIRST AID - SKIN CONTACT:** Wash skin with soap and water. Remove contaminated clothing. Get medical attention if irritation develops or persists.

**FIRST AID - INHALATION:** If you experience difficulty in breathing, leave the area to obtain fresh air. If continued difficulty is experienced, get medical assistance immediately. Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get immediate medical attention. Do NOT use mouth-to-mouth resuscitation.

**FIRST AID - INGESTION:** If swallowed, do not induce vomiting. If victim is conscious and alert, give 2 to 4 cupfuls of water or milk. Call a physician or poison control center immediately. ### 5. Fire-Fighting Measures

**EXTINGUISHING MEDIA:** Alcohol Film Forming Foam, Carbon Dioxide, Dry Chemical, Water Fog

**UNUSUAL FIRE AND EXPLOSION HAZARDS:** Closed containers may explode when exposed to extreme heat due to buildup of steam. Isolate from heat, electrical equipment, sparks and open flame. No unusual fire or explosion hazards noted. Keep containers tightly closed. FLASH POINT IS TESTED TO BE GREATER THAN 200 DEGREES F.

**STORAGE:** Keep containers tightly closed. Isolate from heat, electrical equipment, sparks and open flame. Keep container closed when not in use. Store in a dry, well ventilated place. Keep container tightly closed when not in use.

### PERSONAL PROTECTION

**ENGINEERING CONTROLS:** Use process enclosures, local exhaust ventilation, or other engineering controls to control airborne levels below recommended exposure limits. Prevent build-up of vapors by opening all doors and windows to achieve cross-ventilation.

## 10. Stability and Reactivity

**CONDITIONS TO AVOID:** Avoid contact with strong acid and strong bases.

**INCOMPATIBILITY:** Incompatible with strong oxidizing agents, strong acids and strong alkalis.

**HAZARDOUS DECOMPOSITION:** By open flame, carbon monoxide and carbon dioxide. When heated to decomposition, it emits acrid smoke and irritating fumes.

**HAZARDOUS POLYMERIZATION:** Will not occur under normal conditions.

**STABILITY:** This product is stable under normal storage conditions.

## 11. Toxicological Information

**EFFECTS OF OVEREXPOSURE - EYE CONTACT:** Causes eye irritation. Irritating, and may injure eye tissue if not removed promptly.

**EFFECTS OF OVEREXPOSURE - SKIN CONTACT:** Causes skin irritation. Allergic reactions are possible. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material. Low hazard for usual industrial handling or commercial handling by trained personnel.

**EFFECTS OF OVEREXPOSURE - INHALATION:** High gas, vapor, mist or dust concentrations may be harmful if inhaled. Prolonged or excessive inhalation may cause respiratory tract irritation. Avoid breathing fumes, spray, vapors, or mist.

**EFFECTS OF OVEREXPOSURE - INGESTION:** Substance may be harmful if swallowed.

**EFFECTS OF OVEREXPOSURE - CHRONIC HAZARDS:** Contains Titanium Dioxide. Titanium Dioxide is listed as a Group 2B-"Possibly carcinogenic to humans" by IARC. No significant exposure to Titanium Dioxide is thought to occur during the use of products in which Titanium Dioxide is bound to other materials, such as in paints during brush application or drying. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula. (Ref: IARC Monograph, Vol. 93, 2010) Contains carbon black. Chronic inflammation, lung fibrosis, and lung tumors have been observed in some rats experimentally exposed for long periods of time to excessive concentrations of carbon black and several insoluble fine dust particles. Tumors have not been observed in other animal species (i.e., mouse and hamster) under similar circumstances and study conditions. Epidemiological studies of North American workers show no evidence of clinically significant adverse health effects due to occupational exposure to carbon black.

Carbon black is listed as a Group 2B-"Possibly carcinogenic to humans" by IARC and is proposed to be listed as A4- "not classified as a human carcinogen" by the American Conference of Governmental Industrial Hygienists. Significant exposure is not anticipated during brush application or drying. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of carbon black in the formula.
