## 4. First-Aid Measures

# 6. Accidental Release Measures

# 7. Handling and Storage

#### PERSONAL PROTECTION

# 10. Stability and Reactivity

With symptoms of runny nose, sore throat, shortness of breath and reduced lung function. Persons with a preexisting nonspecific bronchial hyper reactivity.

As a result of previous repeated overexposures or a single large dose, certain individuals may develop sensitization to diisocyanates, or polyisocyanates that may cause them to react to a later exposure to diisocyanates, or polyisocyanates at levels well below the exposure limits or guidelines. The symptoms which can include chest tightness, wheezing, cough, shortness of breath or asthmatic attack could be delayed up to several hours after exposure Extreme asthmatic reactions could be life threatening. Sensitization can be permanent. Chronic overexposure to diisocyanates has also been reported to cause lung damage that may be permanent.

EFFECTS OF OVEREXPOSURE - INGESTION: Harmful if swallowed.

**EFFECTS OF OVEREXPOSURE - CHRONIC HAZARDS:** Overexposure may cause lung damage.
